

**GREENSBURG COMMUNITY SCHOOLS**  
**REGULAR SCHOOL BOARD MEETING**  
**TUESDAY, APRIL 9, 2019 7:30 PM**

Mark Wolter opened the meeting with the Pledge of Allegiance.
