

**GREENSBURG COMMUNITY SCHOOLS**  
**REGULAR SCHOOL BOARD MEETING**  
**TUESDAY, APRIL 10, 2018 7:30 PM**

Those present were: Amy Wickens, Gail Rueff, Mark Wolter, Steve Doerflinger, Jeff Dougan, Shannon McLeod and David Springmeyer. Also present were: Tom Hunter, Cindy Navarra, Tammy Williams and Vicki Houk.

Amy Wickens opened the meeting with the Pledge of Allegiance.

Steve Doerflinger made a motion, seconded by Jeff Dougan to approve the minutes of the March 13, 2018 regular board meeting. Motion carried 7-0. Voting in favor: Amy Wickens, Gail Rueff, Mark Wolter, Steve Doerflinger, Jeff Dougan, Shannon McLeod and David Springmeyer.

Staffing for 2018-2019 is being discussed with administrators. We have teachers retiring and resigning this year, some positions may not be replaced due to lower enrollment numbers.

**NEW BUSINESS:**

Mr. Hunter reported on the current status of Health Insurance for GCS employees. The cost of the plan will not be an increase to the corporation. The plan will remain the same including partnership with Decatur County Memorial Hospital. Mr. Hunter provided board members with a summary of the plan.
