Amy Wickens opened the meeting with the Pledge of Allegiance.

David Springmeyer made a motion, seconded by Gail Rueff to approve the minutes of the August 8, 2017 regular board meeting and the August 22, 2017 Special Board Meeting for the 2018 Budget Hearing. NEW BUSINESS

Mr. Hunter introduced Mr. Bud Smith, with Emcor. Mr. Smith was pleased to present Greensburg Jr. High School with Energy Star Recognition, GJHS being named as one of top schools in the country receiving this recognition of energy efficient school.

Also teachers present were Mrs. Lisa Kramer and Ms. Kim Sebo representing Greensburg Elementary School and from Greensburg High School – Mr. Bryce Mize; Ms. Nicole Batta; Mrs. Heather Haurert and Mr. Mike Myers.

Superintendent's Report:

- a. Tim Kane gave a current update on the building project. 95% of the project has been completed. The boilers will be turned on later this week. The chillers at the elementary school are in the process of being replaced now. Currently the boilers have been removed from the Jr. High School. Most of the paving projects have been completed.
- b. Mr. Hunter reminded board members the ADM count day will be September 15, 2017.
- c. Scott Holdsworth with the Achievement School updated board members with success stories of students earning High School credits through the program being held at GCLC. They had 17

- graduates in 2017. Mr. Holdsworth wanted to thank the board for continuing to allow him to teach these students who face many oppositions in life. For them to have an opportunity to continue to learn in the class setting and earn credits through the Achievement School is very much appreciated. Mr. Hunter commended Mr. Holdsworth, the success of the Achievement School is because of him continuing to reach these students.
