

**GREENSBURG COMMUNITY SCHOOLS**  
**REGULAR SCHOOL BOARD MEETING**  
**TUESDAY, OCTOBER 13, 2015 7:30 P.M.**

Those present were: Steve Doerflinger, Al Moore, Jeff Dougan and David Springmeyer. Also present were: Tom Hunter, Cindy Navarra, Tammy Williams, Vicki Houk and Boris Ladwig from Greensburg Daily News.

Steve Doerflinger opened the meeting with the Pledge of Allegiance.

Al Moore made a motion, seconded by David Springmeyer to approve the minutes of the September 8, 2015 regular board meeting. Motion carried 4-0. Voting in favor: Steve Doerflinger, Al Moore, Jeff Dougan and David Springmeyer.

Jeff Dougan made a motion, seconded by Al Moore to approve the minutes of the September 8, 2015, Budget Adoption meeting. Motion carried 4-0. Voting in favor: Steve Doerflinger, Al Moore, Jeff Dougan, and David Springmeyer.

**OLD BUSINESS:**

Mr. Hunter reported on the fund balances.

Tammy Williams updated the board on curriculum, our teachers have been very busy, we have been videotaping our new teachers to offer suggestions. We have had teachers attending the State Reading Conference and State Math Conference. Continuing to work with curriculum mapping.

Mr. Hunter gave an update to the 2016 Budget Process. We are currently waiting on Form 1782 from DLGF (Department of Local Government Finance). We are expecting to receive it by the end of the year.

Mr. Hunter presented board members with the official ADM report, along with a history of past years enrollment numbers.

Mr. Hunter reviewed the 2016-2020 Bus Contract proposal timeline for the upcoming six routes which will begin with the 2016-2017 school year. An information meeting to all interested bidders will be Friday, October 23, 2015 at central office. The bids will be due in on November 23, 2015, acceptance of the contracts will be presented at the December 8, 2015 school board meeting.

At Mr. Hunter's recommendation regarding an increase to drivers pay for extra-curricular events, Jeff Dougan made a motion, seconded by David Springmeyer to approve the "Transportation Costs Extra-Curricular Bus Driver Compensation" increases as presented. The increase will become effective with the trips driven on and after October 19, 2015. Motion carried 4-0. Voting in favor: Steve Doerflinger, Al Moore, Jeff Dougan, and David Springmeyer. - Mr. Hunter updated the board members on the current renovation at the Jr. High School. New windows are being installed, the ventilation work has begun. A meeting is scheduled on October 14, 2015 with the Construction Company.
- Al Moore made a motion, seconded by David Springmeyer to reappoint Tammie Mulroney to the Decatur County Community Foundation Scholarship Selection Committee. Her second term will run through December 31, 2018. Motion carried 4-0. Voting in favor: Steve Doerflinger, Al Moore, Jeff Dougan, and David Springmeyer.
